THE DEPARTMENT OF EDUCATION AND TRAINING "INFORMATION PRIVACY AND SECURITY POLICY" AND PROCEDURES COVER THE USE OF PERSONAL INFORMATION, AND IN PARTICULAR THAT THE PERSONS PROVIDING CONFIDENTIAL INFORMATION HAVE THE RIGHT TO KNOW HOW IT WILL BE USED.

The Department of Education and Training "Information Privacy and Security Policy" and procedures cover the use of personal information, and in particular that the persons providing confidential information have the right to know how it will be used.

This policy also relates to the use of student/staff stills/video footage/digital images, and any other means of electronic communication. The policy requires that permission must be sought from parents when photographs or digital images of students are to be used outside the classroom environment.

Examples of this would include:

- Photographs taken for the local community paper to promote a school activity/event;
- Digital images taken electronically and placed on the school web site and/or included in a CD-ROM to promote the school;
- Video footage of students used to promote the school.

- Mobile phones/electronic devices and ear pieces that are confiscated are to be collected from Administration (Hamilton Road) the following day by parents/guardians.

- Students who feel unwell are required to contact home via Administration. Students are NOT to use their mobile phone for this purpose.
- The school will not take responsibility for phones/electronic devices or ear pieces that are stolen or damaged while at school.
- Taking still or moving images with camera on school grounds is prohibited without the Principal's permission.

ACCESS TO THE INTERNET IS PROVIDED FOR THE PURPOSES OF EDUCATIONAL RESEARCH AND LEARNING. THE AIM OF THIS POLICY IS TO PROVIDE RULES TO ENSURE APPROPRIATE USE OF THE INTERNET.

STUDENTS AND PARENTS PLEASE CAREFULLY READ AND THEN SIGN THE FOLLOWING AGREEMENT. NO STUDENT WILL BE PROVIDED WITH INTERNET ACCESS UNTIL THIS PARENTAL AGREEMENT IS SIGNED.

STUDENT AGREEMENT

I understand that access to the Internet from Hedland Senior High School must be in support of educational research or learning, and I agree to the following:

- I will not access any news-groups, links, list servers, web pages or other areas of cyberspace that would be considered offensive by generally accepted community standards because of pornographic, racist, violent, illegal or other content.
- I am responsible for monitoring and rejecting materials, links, dialogues and information accessed/received by me on the Internet.
- I will not use valuable Internet time playing games.
- I will be courteous and use appropriate language. I will not use obscene, harassing or abusive language and will report any cases of such language use against me or others to my teacher or the teacher librarian.
- I will follow Hedland Senior High School's "Code of Conduct" at all times.
- I accept responsibility to keep copyrighted material from entering the school. I will not break any copyright laws by posting or distributing copyrighted materials.
- I will not download software, games, music, graphics, videos or text materials.
- Plagiarism (copying) is unacceptable. Therefore I will use any printed material in a correct manner in assignments, listing its source in a bibliography and clearly stating any directly quoted materials.
- I will not reveal personal information including names, addresses, credit card details and telephone numbers of myself or others.
- I will not damage computers, computer systems or networks. If I discover any methods of causing damage I will report them to the teacher or teacher-librarian and will not demonstrate them to others.
- I will follow the current sign-on procedures for access to the computer network.

If I break any of the terms of this agreement I will be denied access to the Internet and may face further disciplinary action as determined by the Technology Committee. I am aware that each situation will be considered separately.
